# Re: 2017 Application for ODSP (Ontario Disability Support Program) Property Tax Credit

You can apply for the ODSP Property Tax Credit for 2017 by mailing or delivering the attached application to City Hall at the address noted on the application form. If you qualify, please complete the attached application form, date and sign Section 7. Remember to include the documentation referenced in Section 4.

- 1. Applicant must solely own and occupy this property as their principal residence.
- 2. Application Deadline is August 31st, 2017.
- 3. Applicant must be receiving ODSP benefits and must provide proof of the maximum monthly shelter allowance.
- 4. Applications must be made on a yearly basis.
- 5. Approved applicants will receive a \$350.00 credit, which the City will apply towards the September tax instalment. The applicant is able to claim the total 2017 taxes as billed on the applicant's income tax.
