WHEREAS the amount of single-use plastics leaking into our lakes, rivers, waterways is a growing area of public concern; and

WHEREAS reducing the waste we generate and reincorporating valuable resources from our waste stream into new goods can reduce Green House Gases significantly; and

WHEREAS the transition to full producer responsibility for packaging, paper and paper products is a critical to reducing waste, improving recycling and driving better economic and environmental outcomes; and

WHEREAS the move to a circular economy is a global movement, and that the transition of Blue Box programs would go a long way toward this outcome; and

WHEREAS the Municipality of the Corporation of the City of Belleville is supportive of a timely, seamless and successful transition of Blue Box programs to full financial and operational responsibility by producers of packaging, paper and paper products; and

WHEREAS the Association of Municipalities of Ontario has requested municipal governments with Blue Box programs to provide an indication of the best date to transition our Blue Box program to full producer responsibility;

THEREFORE BE IT RESOLVED:

THAT Council supports the resolutions made by Quinte Waste Solutions in regards to the Transition to Full Producer Responsibility; and

THAT the City supports the Centre and South Hastings Waste Services Board who would like to transition their Blue Box program to full producer responsibility Effective August 4th 2025; and

THAT the City supports Quinte Waste Solutions in providing collection services should there be mutually agreeable terms with Producers given the benefits of the current integrated solid waste management system; and,

THAT the Province of Ontario maintain the original intent and mandate of the Resource Productivity and Recovery Authority, ensure that it is appropriately staffed and resourced and that stringent waste diversion targets are set and achieved; and

THAT the City supports Quinte Waste Solutions in developing a new RFP for collection and processing services to cover the period from November 7th, 2021 to August 4th, 2025 to ensure consistent service to residents throughout the transition period. A transition date in 2025 would allow for costs associated with new collection equipment to be spread over a longer period reducing transitional costs. A transition date in 2025 would also allow the Board to learn from earlier municipal transition processes and take advantage of any new best practices. This date would align with a new collection agreement with the existing waste collection service agreements of the two largest municipal members of the Board, The City of Belleville and the City of Quinte West; and

THAT the City supports the Centre and South Hastings Waste Services Board in providing contract management services to Producers should we be able to arrive at mutually agreeable commercial terms: and further

THAT the resolution be forwarded to the Association of Municipalities of Ontario and the Ontario Ministry of the Environment, Conservation and Parks; and

THAT The Corporation of the City of Belleville would like to transition their Blue Box program to full producer responsibility August 4th, 2025."
