 - a) Sidney Street Corridor Projects No. 2
 - A verbal presentation was made including draft designs pertaining to this project.
 - Project #2 Tracey/ Sidney Intersection and Project #4 Bell/ Sidney Intersection will be reviewed and presented as a single corridor project. The intersections are closely spaced and therefore cannot be looked at in isolation.
