3) Communications Update

- a. Website Review
- An overview of the newly re-designed BuildBelleville.ca website was provided.
 Staff will be updating each project page and ensure information is accurate. This site will be an important tool for communicating the most up-to-date information to the public.
 - b. Next Steps
- Communications plan is being reviewed and a more detailed plan will be provided in the future. Plan details and the amount of advertising recommended will be based on the level of activity taking place for each project over the course of 2015.
- Clarification was provided around the budget presented in the Communications
 Plan. This plan has been created as a guide for a more detailed advertising plan
 that will be based on project schedules. Seeking external support from a
 communications professional was necessary to assist with re-design of the
 website during the transition of two new staff members who provide
 communications support for Build Belleville projects. Moving forward, any
 external communications support will take place as needed and is not a monthly
 budgeted item.
- Detailed plan will be presented once the Project Coordinator has met and received updates from Project Managers. The final details will be included in a future report to Council.

4) Project Status Update

- a. Pedestrian Footbridge
- A presentation regarding the preliminary design for Catherine Street Pedestrian Bridge replacement was provided by Ray Ford.
- This project is not currently part of Build Belleville. Staff has recommended it be brought forward to Council through the Mayor's Implementation Team.
- Catherine Street is the City's top priority for pedestrian bridges. This project has been a capital budget issue since 2011 and is identified in the City's Transportation Plan.
- A significant portion of the assignment is to focus on the architectural design, landscaping and decorative lighting necessary to incorporate the replacement

- structure into the designs planned for the City Centre (Downtown) Revitalization Project.
- A summary of the eight proposals received was provided. Final recommendation based on demonstrated understanding of the project, a detailed and comprehensive work plan, and experience of a Lead Designer with a high level of structural architecture experience in pedestrian bridges.
- Bridge is currently being monitored for safety and the construction contract is planned for early 2016.

THAT the Mayor's Implementation Team recommends to Council that the Catherine Street Pedestrian Bridge Replacement project, being a prominent infrastructure project located within the City Centre requiring coordination with the Downtown Redevelopment and Revitalization project, be overseen by the Mayor's Implementation Team."

- RFP being issued January 30, 2015. RFP for supply of street light and traffic signal poles and luminaires is being issued separately to encourage interest from multiple bidders.
- Bid considerations include the need to meet design specifications and price.
