7.1 Annual Ridership Statistics for January and February 2018 – Report DE&OS-2018-TAC-05

8. GENERAL BUSINESS

8.1 Safe Driver Awards Information

Staff presented information about Belleville transit entering into a safe driver recognition program with Infrastructure Health and Safety Association IHSA. Each driver that completes a year of driving without a preventable collision will receive a safe driving pin with the years of safe driving identified, as well as a wallet card. The awards will be issued during a driver breakfast meeting in May.

8.2 Loyalist College Transit Promotions Project

Loyalist College Journalism, Broadcasting and Public Relations programs are working together with Transit staff to develop a promotional package for Transit. The package will include print, radio and video material that can be used to market Transit. This material will be ready by June 2018.

8.3 Discussion of possible Seasonal Trolley Route

Staff presented a proposal of a Historical Trolley Tour route for the City of Belleville. This service would operate throughout the city providing service to the waterfront parks, hotels, restaurants and museums. The service would be operated with the use of partners and sponsors to assist in covering the cost.

8.4 Transit Terminal Concessions RFP

There were no submissions received to operate the concessions counter at the terminal. The current vendor has agreed to remain on site until the end of April. A follow-up RFP for the installation of vending machines will be issued and Transit Staff are pursuing the possibility of purchasing a transit pass vending machine to be installed on site.

9. NEW BUSINESS AND INFORMATION MATTERS

- 9.1 The request was made for Transit Staff to approach Loyalist College again to discuss the possibility of entering into an agreement for a U-Pass for all Loyalist College Students. Previous discussions with the College regarding this option has not been successful, however with the increased transit ridership and increased student numbers this may now be a opportunity they would like to discuss. Staff will make contact with the college to initiate the discussion.
- 9.2 There was considerable discussion regarding the Mobility Bus Service, specifically the Taxi service coverage on weeknights and weekends. There are reports that the taxi service will not provide service up to the required 10:00 PM time. Staff will contact the service provider to review booking practices to ensure service hours are being met.
- 9.3 Concerns were raised about the mobility service and the inability to be able to call and book service with less than 24 hours' notice. Staff was asked to review the current agreements and determine if mobility bookings can be made through the taxi dispatch. Staff were also requested to review the possibility of mobility passengers booking a regular taxi and being able to show their mobility pass as payment.
