8. GENERAL BUSINESS

8.1 Discussion of Seasonal Trolley Route - Progress

Staff presented information about the Trolley Route. The service has been approved through the budget process, with the requirement that sponsors be sourced to cover the operating cost of the service. Transit staff is working with Belleville and Quinte Tourism to source sponsors. The service will launch Friday June 1. There will be a Media and VIP trip be operated at 9:45 AM before the first scheduled trip. TAC members are invited to attend the ride.

8.2 Transit Terminal Vending RFP

The RFP for a vending contractor closes at 1:00 PM tomorrow. There have been four (4) takers of the document, it is expected that a vendor will be chosen.

8.3 Transit Terminal Transit Pass Vending Machine

Transit Staff have sourced a vendor to purchase a transit pass vending machine that will dispense the current passes, as well as the future electronic passes. The unit will need to be tested to confirm its capabilities, and if successful constructed and delivered. It is expected to be delivered by the end of May.

8.4 Loyalist College U-Pass

Transit Staff made contact with Loyalist College to discuss the possibility of entering into an agreement to initiate a College U-Pass, with students paying for a transit pass as part of their tuition. The College is very interested in entering into an agreement as long as the service provides trips to Trenton. This service will be through Quinte Access. Staff will meet with Quinte Access to attempt a solution.

9. NEW BUSINESS AND INFORMATION MATTERS

9.1 There was discussion about the large shelter at the Terminal regarding the run off of snow melt and rain, it is leaking under and through the shelter.

Staff will contact Facilities to check on the possibility of providing a sealant to the bottom of the shelter to prevent this from occurring.
