WHEREAS the current Ontario Autism Program falls short of allowing children with ASD to access the evidence-based, intensive ABA (Applied Behaviour Analysis) therapy that they require in order to learn critical learning, communication and social skills; and,

WHEREAS the current Ontario Autism Program has forced many ABA therapists to leave the field and is jeopardizing many more positions, making access to ABA therapy more difficult while sending children to school without the skills they need to be successful; THEREFORE, be it resolved

THAT the Council of the Corporation of the City of Belleville requests the Minister of Children, Community and Social Services change the Ontario Autism Program in the following ways:

- 1. Provide and restore access to intensive ABA therapy by April 2020 instead of April 2021
- 2. Confirm the government's unwavering commitment to maintain the minimum funding level of \$600 million annually for the provision of service to families

THAT a copy of this resolution be forwarded to Premier Ford, Local Members of Provincial and Federal Parliament and the Minister of Children, Community and Social Services and AMO (Association of Municipalities of Ontario) for wider distribution.
