# 10. NEW BUSINESS

Councillor Carr referenced the motion from the December 11, 2017 Council Meeting regarding cannabis retail stores and the establishment of an interdepartmental working group. He requested an update on the progress towards establishment of this group. The Director of Engineering and Development Services, Rod Bovay, advised that planning staff are continuing work on related issues and reviewing both Federal and Provincial guidelines however the committee has not been established as of yet. Councillor Carr noted the sooner this is established the better with the potential availability of provincial financial assistance for municipalities.

Councillor Panciuk agreed with Councillor Carr in that the City needs to move ahead regarding the cannabis issue for public safety and also to be ready as a community. He also spoke about the Community Arts & Culture Fund deadline.

Councillor Panciuk noted the BDIA had expressed concern to him about not being consulted regarding the Ontario Main Street Revitalization Initiative – allocation of funds. The Director of Finance/Treasurer, Brian Cousins, responded by referring to Consent Item 8.b.6. (Ontario Main Street Revitalization Initiative) and explained how the Province (through the Association of Municipalities of Ontario) identified conditions such as the funding is for improvements to downtown mainstreets and also that municipalities must have a Community Improvement Plan. He explained that during the 2018 Budget, Item 7-02 was approved at \$74,000 and Council approved putting the Main Street Revitalization Initiative towards the Façade Improvement Program.

Councillor Panciuk also referred to a petition he received from residents of West Park Village expressing concern over a change in the purpose of Hastings County's "Home of Good" project. Residents are concerned changes have been made since the Planning Advisory Committee approved the application. The Director of Engineering and Development Services, Rod Bovay, responded that the zoning is not related to people but property use. He explained that Hastings County was up front regarding the partner agencies invoved in the project and the Planning Advisory Committee's knowledge at the time of the application's approval.

Councillor McCaw spoke about discussions during Operating Budget regarding Hastings County run long term care facilities. She provided a hand-out listing a statistical summary of Belleville residents in Centennial Manor and Hastings Manor. She asked whether the City and Hastings County have met on the issue. The Chief Administrative Officer, Rick Kester, advised of a legal opinion forthcoming with a report to follow.
