10. NEW BUSINESS

Councillor Carr requested a Staff report on the three processes, identified in the Integrity Commissioner's report, plus three additional selection processes, outlining any non-compliance issues with the City's hiring policy and what remedial action has been taken as a result of non-compliance to restore integrity in the City's hiring policy and providing candidates meeting the minimum qualifications the opportunity to be considered for those positions. He also requested that the staff report outline the taxpayers dollars that have been spent as part of training to meet minimum standards for any position.

Councillor Sandison spoke about an issue in Ward 2 with blue box and garbage collection interfering with Canada Post delivery. He has had discsussions with Quinte Waste Solutions in hopes of educating drivers regarding placement of empty green bins and blue boxes.

Councillor Sandison directed a question to the General Manager of Environmental Services, Perry DeCola regarding extension of water services past Kempton Avenue and availability for Sidney Street residents to hook-up to City water. General Manager DeCola advised that residents are able to get serviced. The Chief Administrative Officer, Rod Bovay, advised that at least one homeowner is aware and has connected. Councillor Sandison also noted that all staff have an annual performance evaluation and believes Councillors should also be evalutated by residents. He will bring forward a motion under Notice of Motion.

WHEREAS, public health care consistently ranks as the top priority in public opinion polls; and,

WHEREAS, Public Health provides vital health promotion and prevention services based on the unique demographic and economic, social, and cultural needs of our communities; and,

WHEREAS, the evidence from hospital amalgamation in Ontario and across Canada is that they have cost billions of dollars and have not yielded the promised administrative savings but have taken money away from frontline care; and.

WHEREAS, there is no evidence to support the proposed closure of 25 out of 35 local Public Health Units, the closure of 12 of 22 local ambulance dispatch centres, and the closure of 49 out of 59 local ambulance services; and,

WHEREAS there is a deep consensus among virtually all stakeholders that increasing acuity in our long-term care homes requires additional staff and resources, not cancellation of the two special funds and real dollar cuts to per diem funding of our long-term care homes; and,

WHEREAS our local hospitals have been downsized for an entire generation and cannot meet population needs while sustaining real dollar cuts to hospital global budgets

THEREFORE BE IT RESOLVED:

THAT The Corporation of the City of Belleville calls upon the Ontario government to halt the closures of, mergers of, and cuts to our local health care services including Public Health Units, land ambulance services, hospitals and long-term care homes and.

THAT this motion be circulated to Ontario Premier, Doug Ford; Todd Smith, MPP Prince Edward-Hastings; Daryl Kramp, MPP Hastings – Lennox & Addington and the Association of Municipalities of Ontario.

He also spoke about attending the Foxboro Santa Claus Parade on Saturday, December 7. He also attended the National Day of Rememberance of Violence Against Women event.

Councillor Kelly spoke about the success of the BDIA's Enchanted Holiday Night Market event which was attended by approximately 3,000 people.

Councillor Malette noted attending the following events as Mayor of the Month: 8 Wing Trenton ceremony for former City of Belleville mayor Ross McDougall who was made honourary colonel for 2 Air Movements Squadron; an Indigenous Blanket Ceremony and the Volunteer & Information Quinte Volunteer Recognition Night. Councillor Malette also congratulated the BDIA on the success of the Enchanted Holiday Night Market event.

Councillor Thompson announced that Operation Red Nose has started and there were 35 new volunteers this year. They are always needing more volunteers.
