## **10. NEW BUSINESS**

Councillor McCaw requested an update on the Sidney Street construction. Director of Engineering & Development Services, Rod Bovay, provided information on paving taking place from Wednesday, May 30 until the end of the week. Councillor McCaw also requested a status update on the erosion of the Bridge Street bridge.
