A Public Meeting, as noted above, will be held on August 15, 2024 at 3:30 P.M. to consider an application under Section 45 of the Planning Act submitted by Julie-Ann Bellis on behalf of Jason Bellis.

The minor variance application requests relief from the required maximum lot coverage, and the minimum front and rear yard depths.

How to ask a question during the meeting:

Members of the public will be able to provide comments and ask questions during the meeting. The Chair of the meeting will open the floor to questions or comments from members of the public after the application has been introduced and the applicant or their agent has answered any initial questions from the Committee. Each member of the public wishing to speak will be allocated up to five (5) minutes in which to provide comments and/or questions regarding the application.

Any person may attend this meeting and/or make written or verbal representation either in support of or in opposition to this application using methods explained above, or you may be represented by counsel for that purpose.

How to be notified of the decision:

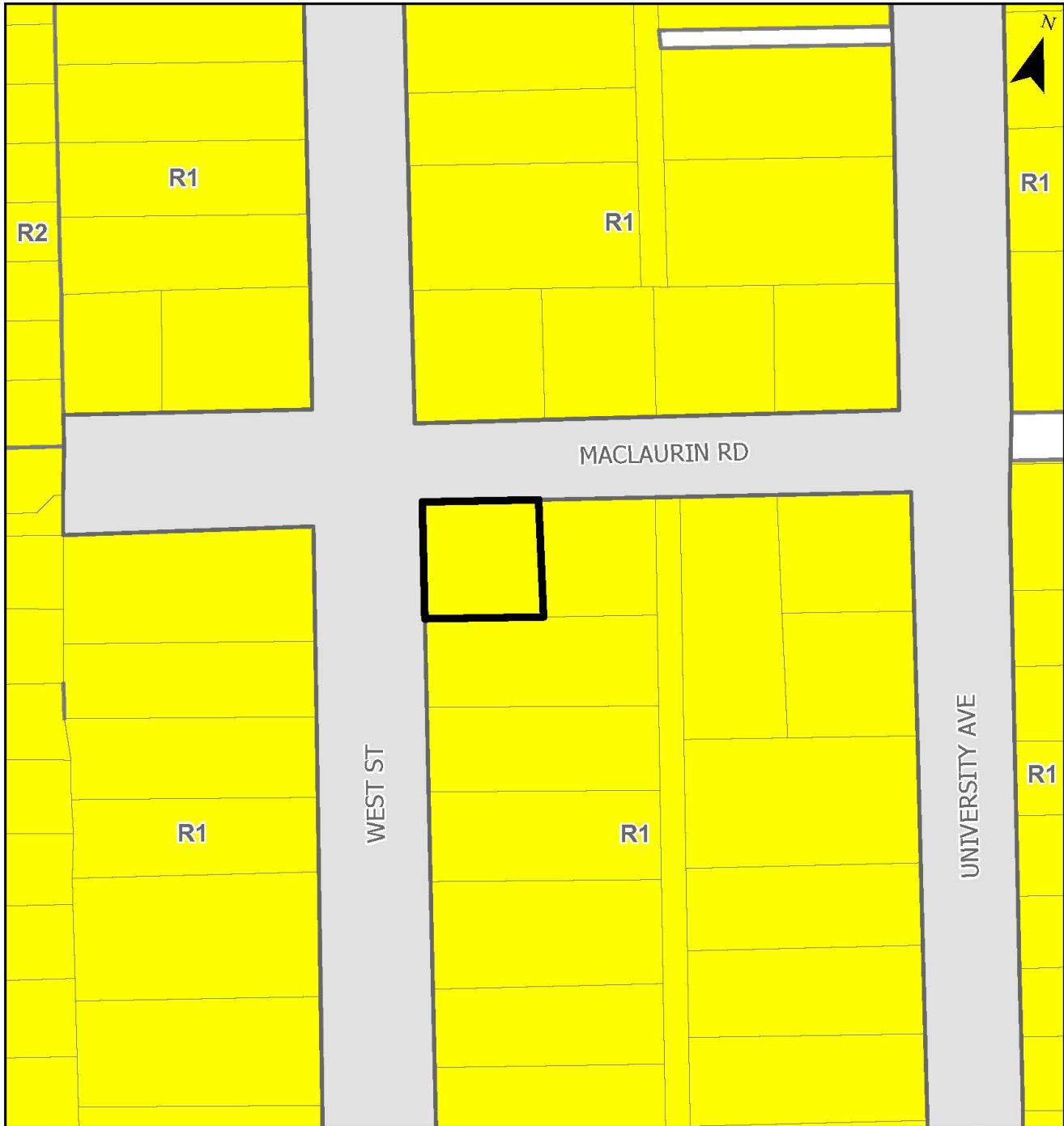
